Once again, the Lake Jordan HOBO Association's annual Lake Clean-Up resumed with outstanding results. On Saturday, April 17, 2021, HOBO members, community volunteers, and lake neighbors gave their time and energy by cleaning up Lake Jordan after an extra year off due to the pandemic.

A total of 3.36 tons of trash and debris was collected by over 150 volunteers. As usual, the vast majority of the trash retrieved was plastic water bottles, aluminum cans, abandoned trot line markers and damaged water floats, but also included a half-sunk paddle boat, a shattered No Wake buoy and too many old tires to count.

As with previous years, it took the efforts of many volunteers and sponsors to make this year's clean-up a success. A big "Thank You" to the Holtville-Slapout Fire Department for all their help on the day of the clean-up and to Alabama Power for their continued, annual support by providing trash bags, gloves, grabbers and t-shirts to our many volunteers. 
There is no entry fee to participate, but we are asking for donations for Camp Wheeze-Away which can be made on our website at the time of registration.

No Wake Zone for Evening of 3rd of July

A mandatory No Wake Zone will be implemented by ALEA Marine Police for the entire width of Lake Jordan from Lake Jordan Dam to Rusty Hook Slough and Ski Club Inlet from 6:00 pm on July 3rd, 2021 to 6:00 am on July 4th, 2021.

A "No Wake Zone" is an area within which vessels are required to travel at idling speed – slow

speed that creates no appreciable wake. All boat operators should use proper navigation lighting and not use alcohol while operating a vessel. ALEA also encourages the usage of personal flotation devices.

HSFD Chief Todd McCarley encourages all boaters and passengers to wear a personal floatation device (PFD) while in a boat at night.





Splash! 5 Great Ways to Keep Your Dog Safe Around Water

Dog Checkups & Preventive Care We all love lakes, the ocean, ponds, pools, and being on boats! And many dogs do, too. Here are a few water safety tips for your dogs:

1. Not all dogs are good swimmers.

In fact, some dogs don't swim well or naturally and can drown as fast (or faster) than a person. Don't assume your dog will take to the water and be able to stay afloat. Try them out in shallow water before a big excursion.

2. Preserve a life.

If you're out in a boat or raft, your dog should have a life preserver on – no exceptions! It not only will keep them afloat, it makes them easier to spot and gives you something to grab if they jump or fall in.

3. Sink or swim?

Dogs that are heavy on land are way heavier in the water when you're trying to pull them back into your boat. Make sure you can handle your dog out of your and their natural environments.

4. Keep your dog close!

Even dogs that swim well can tire very quickly, even faster than you, because they don't understand the concept of resting or treading water –



they just swim and swim, until they can't anymore. When swimming with your dog, don't let them swim too far away from you, because they could get into trouble quickly.

5. Don't force your dog into the water.

If your dog doesn't like the water, don't make them go in! It could scare them and won't be fun for them at all!

Alabama Alligator Hunt Registration Now Open

The Alabama Department of Conservation and Natural Resources has opened online registration for its highly coveted alligator hunting tags. The tag will allow a group of hunters to take one alligator during the hunting season that begins in August.

The online registrations began June 1, 2021 and will

continue through July 14 at 8 a.m.

Interested hunters can apply for a tag allowing them to hunt alligators in five separate zones across the state. A total of 260 non-transferrable tags will be awarded through a random computer selection process, and hunters who apply for tags year after year will have better odds.



Hunters can apply in multiple zones but can only be selected in one zone per year. The names of those who are selected to receive a tag, and some alternates will be posted on July 14 at 12 p.m.

The administrative fee to apply for an Alligator Possession Tag is \$22 and individuals may register one time per zone. While the tag is free, the selected hunters and their assistants are required to have valid hunting licenses in their possession while hunting.

Applicants who receive a tag must complete an online alligator training course before accepting their status as a hunter or alternate. If a hunter does not confirm their status by July 21 at 8 a.m., their tag will go to an alternate.

The hunting zones and schedules are as follows:

SOUTHWEST ALABAMA ZONE – 100 Tags Locations: Private and public waters in Baldwin and Mobile counties north of interstate 10, and private and public waters in Washington, Clarke and Monroe counties east of U.S. Highway 43 and south of U.S. Highway 84. 2021 Dates: Sunset on August 12, until sunrise on August 15. Sunset on August 19, until sunrise on August 22. COASTAL ZONE – 50 Tags Locations: Private and public waters in Baldwin and Mobile counties south of Interstate 10. 2021 Dates: Sunset on August 12, until

sunrise on August 15. Sunset on August 19, until sunrise on August 22.

SOUTHEAST ALABAMA ZONE – 40 Tags Locations: Private and public waters in Barbour, Coffee, Covington, Dale, Geneva, Henry, Houston and Russell counties (ex-

> cluding public Alabama state waters in Walter F. George Reservoir/Lake Eufaula and its navigable tributaries). 2021 Dates: Sunset on August 14, until sunrise on September 6.

> WEST CENTRAL ALA-BAMA ZONE – 50 Tags Locations: Private and public waters in Monroe (north of U.S. Highway 84), Wilcox and Dallas counties. 2021 Dates: Sunset on August 12, until

sunrise on August 15. Sunset on August 19, until sunrise on August 22.

LAKE EUFAULA ZONE – 20 Tags Locations: Public state waters only in the Walter F. George Reservoir/Lake Eufaula and its navigable tributaries, south of Alabama Highway 208 at Omaha Bridge (excludes Eufaula National Wildlife Refuge). 2021 Dates: Sunset August 20, until sunrise October 4.

Each tag holder will be allowed to harvest one alligator during the season. There is no minimum length, except in the Lake Eufaula zone, where the minimum length is eight feet. The use of bait is prohibited. Hunting hours are sunset to sunrise, except in the Lake Eufaula zone where hunting is allowed day or night.

The DCNR says Alabama is believed to be the first state to limit alligator harvests, doing so in 1938. The American alligator was placed on the Endangered Species List in 1967 and removed in 1987. Alabama has allowed controlled alligator hunts since 2006. For more information or to register, see the Alabama Department of Conservation and Natural Resources website.

Go Fish, Alabama! Program Teaches Basics of Fishing

Have you ever wanted to learn the basics of fishing but didn't know where to begin? The Alabama Department of Conservation and Natural Resources' (ADCNR) Wildlife and Freshwater Fish-

eries Division (WFF) has developed a beginner fishing course just for you.

WFF's "Go Fish, Alabama!" program provides adults and families with little-to-no fishing experience an opportunity to fish under the guidance of a skilled fishing mentor. The program is for anyone interested in

learning how to fish, socializing outdoors, putting fish on the dinner table, or simply enjoying the thrill of the catch. Each event is conducted in a safe, welcoming and constructive environment.

"The goal of the program is to highlight the benefits of spending time outdoors while learning about conservation, including the importance of purchasing a fishing license," said Justin Grider, WFF's R3 Coordinator (Recruitment, Retention and Reactivation). "When you purchase a hunting, fishing or Wildlife Heritage license, all of those funds are reinvested in conservation efforts throughout the state. Fisheries and wildlife man-

agement, habitat restoration, land conservation, public access to outdoor recreation, and state Conservation Enforcement Officers are just some of the ways your license dollars make Alabama

one of the best places in the country to fish or hunt."

During the events, all the necessary bait, equipment and tackle are provided. However, you will need to bring a cooler to take home your catch. The events take place at State Public Fishing Lakes, State Parks lakes, city lakes and other fishing desti-

nations throughout the state. For select events, a \$10 registration fee may apply. Online registration is required to attend.

Lake Jordan Home/Boat Owners Association Minutes of the Quarterly Membership Meeting April 26, 2021

The Lake Jordan Home Owners/Boat Owners Association Quarterly Membership Meeting was called to order by President Jeff Royal at 7:00 pm on April 26th, 2021 at Camp Chandler on Lake Jordan.

President Royal thanked everyone for being there and declared that a quorum was present to conduct business. He welcomed everyone, and new members and guests introduced themselves.

A motion was made and seconded to approve the minutes from the January 25th, 2021 Quarterly HOBO Association meeting. The motion carried.

HOBO Treasurer Brett Wilkinson presented the Financial Report dated March 31st, 2021 with an ending non-restricted cash balance of \$37,213.39. He also had the 2020 year-end financial report available. Last year we had an increase in income over expenses of approximately \$4,700.00. Jeff reiterated that 82% of the funds that are received by the HOBO Association are given back to the community through support for the local fire departments, Camp Chandler, water testing program for Lake Jordan, etc. The financial statement outlines where all HOBO expenditures are made.

Jeff introduced the new director for YMCA Camp Chandler, Danny Lawless, and Camp Chandler Board Member, Lainie Cleghorn. On behalf of the HOBO Association, Jeff presented them with the annual financial contribution. The annual check is used to sponsor campers to attend the summer camp each year at Camp Chandler.

Committee Reports

Lake Clean-Up – Jeff commended Allan and Brenda Basnight for the outstanding job they did making the Annual Lake Cleanup that occurred on April 17th, 2021 a huge success again this year. Gayla Littlejohn reported that there were about 150 volunteers that participated and approximately 3.36 tons of garbage was pulled out of the lake. The Basnights asked Gayla to thank everyone who participated, and they look forward to seeing everyone again next year. Water Quality – Judy May reported that the Alabama Water Watch is not ready to hold an in-person recertification class at this time. They are currently working on possibly having a virtual bacterial monitoring certification class. There are about a

dozen testing sites around the lake that are tested each month. Please contact Judy at frudymay@elmore.rr.com if you are interested in being certified.

Lake Safety – Dave Kowalski reported that the missing hazard buoys are in the process of being replaced by the Marine police. The mandatory No Wake Zone will be implemented by ALEA Marine Police for the entire width of Lake Jordan from Lake Jordan Dam to Rusty Hook Slough and Ski Club Inlet from 6:00 pm on July 4th to 6:00 am on July 5th. ALEA will be enforcing the mandatory no wake zone. Holtville Slapout Fire Department and ALEA Marine Police encourage the use of personal floatation devices (PFDs) for everyone while in a watercraft at night. Safety reminder – Please make sure all outlets near the water are GFI protected to prevent the possibility of electrocution.

Membership – Kim Adams was pleased to report that 2021 membership renewals are up to 230. We generally end the year with approximately 300, so we are off to a good start.
