# Lake House Winterizing Must-Haves

(Last Updated On: December 2, 2021)

When the temperature starts to drop during fall, many lake houses, which are often used as a retreat place during summer, are also being prepared to stand the change of weather.

Boats are removed from the water to safety, and the entire property is assessed in preparation for the coming winter. Lakeside homeowners call this winterizing.

Winterizing not only prepares your lake house for the cold weather should you decide to spend a cozy winter with your family on it.

It is also meant to protect your property in general for the cold season that may bring a lot of damages if neglected.

Think of frozen pipes, cracked woods, and furniture that is not suited for winter.

To make sure that your lake house is winter-ready, here are some lake house winterizing must-haves that you can review.

## For Your Cabin

#### **CHECK THE PIPES**

When preparing your cabin for the winter, make sure to check the pipes for leaks and cut off the water at the main supply point, especially when you don't plan on coming back as often when the cold sets in. This will prevent water from coming into the pipes inside the lake house, preventing potential burst when it freezes, which can happen. Make sure to drain all the water in the pipes, toilet, and other items that has water on it.

#### MANAGE THE THERMOSTAT

Setting the thermostat with the correct temperature is necessary when you won't be using your lake house much during winter. The temperature should be set at a lower degree but on, to keep from things freezing during cold days. Most lake house property owners invest in smart thermostats to monitor and control the temperature inside the lake house wherever they are.

#### CHECK FOR WOODEN CRACKS AND AIR

Most lake houses are made of wood. Part of the winterizing preparation is to check for possible cracks that can further be damaged during cold weather. At the same time, look for air leaks on electrical wiring, windows, and doors. If you find any, make sure to seal them immediately to keep the cold air out of the property.

#### WINTERIZE YOUR FIREPLACE

Clean the ashes and other dirt that accumulated on your fireplace. If you must, call the service of a professional to inspect and clean your fireplace chimney. Professionals can detect problems that can cause fire or carbon monoxide poisoning. This should be done annually, preferably before the winter season. Add a chimney cap to prevent rain, snow, and other debris from entering your fireplace as well.

## **Outside The Property**

#### **CHECK YOUR APPLIANCES**

If you think you have less time to visit your lake house during the winter, make sure to check all your appliances if they are still working correctly. Check for faulty switches that might cause trouble when lightning strikes or when there is a snowstorm. It is also necessary to unplug all the appliances to save a bit, especially when you won't be visiting much.

#### CHECK THE BOATS

Clean your boats, including the swim ladder, raft, life jackets, and other equipment. It is advisable to cover or wrap your boat if you dock and store it outside of the property. Check also for any breaks and cracks and check the motor if it needs to be lubricated. Make sure to remove any batteries as well, if there are any. These might freeze and can cause accidents.

#### **CLEAN THE YARD**

Check your lawn and mow if needed. Check also the gutters for any dirt and inspect the roof for damages. If there are any leaks, repair them to avoid leaks, especially if there is snow coming in the winter. Store all outdoor furniture like tables, fire pits, grillers, and others inside. Some types of furniture might freeze during snow or react badly to the cold. Make sure to secure them properly.

#### SECURE THE PROPERTY

Make sure to check and secure everything within your property. Store away and lock important items on a safety box. Close the windows and blinds or curtains and check your alarms. It is recommended to put up a smart alarm system to monitor your property even if you are away. You can also add security cameras in your front yard for added security. There are a lot of excellent and affordable cameras that can withstand the cold weather and even snow, If you can, you might also get a service of property management to help you secure and monitor your property. You can have the option to hire them during the winter months only, and they will take care of your cabin for you. with gas, make sure to empty the gas tank and thoroughly clean the equipment.

If you have a garden hose outside of your cabin, make sure to remove excess water that might freeze. Coil it and store it inside your garage as well.

As for the rakes and other metals, clean them thoroughly and spray WD-40 to keep them in top shape.

Even if you are not going to visit much, make sure to check emergency and first aid kits and replenish them, if necessary. Remove any expired items. Winterizing your lake cabin means putting it in "sleep mode" to keep it secure if you think that you'll be gone for the entire winter or a more extended period. You have to make sure to take all the necessary precautions to keep your lake house cabin in good shape. The process will help you save a lot of cost for repairs and other problems that may arise in the long winter months.

# **Cold Weather Tips**

When cold weather strikes, it usually means a spike in energy use. By making a few easy adjustments and planning for the season, you can keep costs down while keeping your home warm. The best part... you're also saving energy.

Set your thermostat to 68 degrees while you are away.

Don't invite cold air in. Shut your garage door to keep out the cold and cut costs.

Open your blinds during the day.

Close all louvers and vents in the attic or foundation walls during the winter - but be sure to open them when the weather turns warm.

Check your water heater. If your water heater tank is warm to the touch, believe it or not, it may need a blanket. Check with the manufacturer to see if it has an R value of at least 24, and if not, try adding a custom-made insulating blanket, which can reduce heat loss by 25%-45%. They are super easy to install and available at most home improvement or building supply stores.

Upgrade your heating and cooling system to a heat pump. Heat pumps utilize electricity to move heat from a cool space to a warm space, making the cool space cooler and the warm space warmer.

#### Rethink your fireplace.

Although a crackling fire in the fireplace can make a room appear to be warm and cozy, fireplaces are often a deterrent to energy efficiency because a lot of the heated air escapes up the chimney. A fireplace designed for providing heat eliminates this problem through a draft which supplies the fire with outside air rather than air from the room.

**Zone heat** — only use portable electric space heaters in the room or area you are in. Buy models that are thermostatically controlled.

Use an electric blanket at night. An electric blanket is more economical than heating the entire house all night long. Another option - swap out your bedding to flannel sheets or heavier blankets.

Cover up cold feet. Research shows we are more sensitive to feeling cold when our toes are exposed, and women are more likely than men to have cold feet. Wearing comfy wool socks can help you feel warm all over.

# Lake Jordan Home/Boat Owners Association Minutes of the Quarterly Membership Meeting October 25, 2021

The Lake Jordan Home Owners/Boat Owners Association Quarterly Membership Meeting was called to order by President Jeff Royal at 7:00pm on October 25, 2021 at Camp Chandler.

President Royal thanked everyone for being there and declared that a quorum was present to conduct business. Jeff welcomed everyone, and new members and guests introduced themselves.

A motion was made and seconded to approve the minutes from the July 26, 2021 Quarterly HOBO Association meeting. The motion carried.

Brett Wilkinson presented the Financial Report dated September 30, 2021 with an ending non-restricted cash balance of \$35,847.51. The Financial Report showed a bank balance of \$56,700.56. \$18,988.85 of that amount is earmarked for the Fireworks Show Fund, and \$1,864.10 is earmarked for the Scholarship Fund; both of which were generated from fundraising efforts.

Jeff presented a HOBO Board approved amendment (to the HOBO Association Bylaws) to the Membership for approval. The proposed amendment was to Section 1 Article 3 pertaining to Officers serving on the Board. The following language was proposed for adoption: "An Officer must be a current member, in good standing, for at least (1) one year prior to being elected." The amendment was adopted and passed.

The next order of business was regarding the elections for the HOBO Officers (President, Vice President, Secretary and Treasurer) for 2 year terms starting in January 2022. There is also a vacancy on the Board of Directors that needs to be filled. The October 25, 2021 meeting was when the new slate of Officers and Board members were to be elected; however, the Nominating Committee has received no nominations or interest from individuals that are willing to serve. The Bylaws allow for anyone who has been a dues paying member for 1 year and is current on their dues to serve as an Officer or a Board member. People need to participate in order for this organization to continue to be successful. Kim Adams, Membership Chairperson, reminded everyone that we have 273 paid family memberships. The call for service has been in the newsletter, but it was suggested that the call be put out on the Facebook page, website and even possibly sending out a separate mailing asking for volunteers. The statement was made that if members aren't willing to participate, the organization will dissolve, and nobody wants to see that happen. Jeff reiterated how much he's enjoyed his time as President. He is at the end of serving his 2nd two-year term, and it is time for a new person to fill that role. He will be glad to assist the new President in any way if his help is needed. Jill Murchison, as a member of the Nominating Committee, suggested deferring the elections until the January 2022 meeting to allow for more time to receive nominations. Please contact Bob Carlisle, Jill Murchison, Dee Hartley or Tim Owen if you would like to serve or nominate an individual to serve as an Officer or on the Board of Directors. #### **Committee Reports:**

Water Quality - Judy May reported that Alabama Water Watch has still not resumed in person certification classes. They are working on a virtual bacterial and chemical monitoring class followed by a field day class conducted a certified individual trainer during the 1st week of December. Please contact Judy at 334 567-7327 for additional information and questions about the Lake Jordan Water Monitoring program. She also reported that she has found a fair amount of E. coli in the Lake and is uncertain as to what is causing it. She suggested that the good news is that the E. coli is being found after swimming season is over. The Coosa River Keepers test the water weekly during swimming season. The Lake Jordan monitors test year around. Also, because Lake Jordan is a rapid flowing river, all the water cycles though the lake and out within a 2-week period. Hopefully, as she continues to test, the replacement water will show less.

**Lake Safety -** Dave Kowalski was unable to be at the meeting. Jeff reported that there are several buoys missing in hazardous areas on the like. Those have been reported to the marine police. Jeff reminded the membership that it is not the responsibility of the HOBOs to replace the buoys. The HOBOs only report the need for them. Alabama Power provides the funding to purchase the buoys and the Marine Police are responsible for the installation of them. A couple of the buoys have been missing for a while and the response is that there is no supply of replacements available at this time.

HOBO Newsletter and Publicity - Lisa Lawrence requested that all articles for inclusion in the next newsletter be sent

to her at llawren3@gmail.com by December 1st, 2021. Article submissions as well as suggestions for articles are always appreciated. Don't Forget - The Newsletter is available for view online at www.lakejordanhobo.org.

Environmental - Jeff reported that there have been reports and issues with silt affecting properties caused land clearing in the area. Alabama Power has been proactive with helping these homeowners to resolve the issue. Please look for forthcoming detailed information on the website and in a future newsletter on what to do if you find yourself dealing with similar issues.

**Memorial and Worship -** Sunday Worship Services at the Memorial and Worship Site at Bonner's Landing will resume the weekend of Memorial Day 2022 and will continue until Labor Day Weekend 2022.

**Membership -** There are currently 273 paid memberships in 2021. Remember, dues can be paid on the HOBO website through PayPal. Also, please consider adding a donation for the fireworks. All donations to the HOBO Association are tax deductible.

Alabama Power asked Jeff to inform the membership that the next Lake Jordan Water Draw down is scheduled for the Fall of 2023 and the water will remain down for approximately 2 weeks.

There being no further business, Jeff Royal adjourned the meeting. The next meeting will be held on Monday, January 24th, 2022 at 7:00 pm (6:30 pm if you want to eat) at Camp Chandler.
