## THE COOSA RIVER SWIM GUIDE IS ALMOST HERE!

Every summer from Memorial Day to Labor Day, Coosa Riverkeeper tests water quality at popular swimmin' holes all along the Coosa River. We test for harmful pathogens, like E. coli, and give you a green, yellow, or red warning to ensure you can make informed decisions on where you recreate! You can also find other water quality parameters each week like dissolved oxygen, pH, turbidity, and more!



**JUMP IN!** If you see a green alert, it is all good!



**HOLD UP!** Proceed with caution—cover all cuts/bites, and consider not putting your head underwater.



**WAAAAIT!** High concentration of E. coli detected and we recommend not swimming in that location at that time.

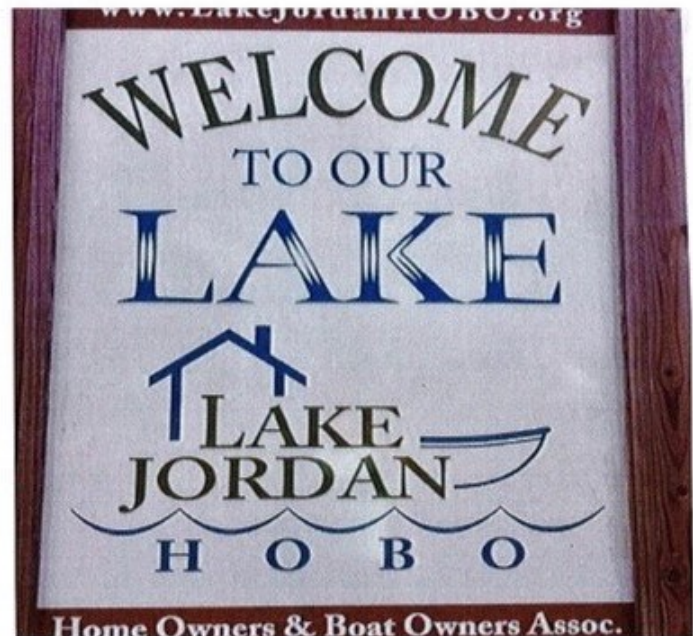

# Lake Jordan Home/Boat Owners Association

## Minutes of the Quarterly Membership and Annual Business Meeting January 30, 2023

The Lake Jordan Home Owners/Boat Owners Association Quarterly Membership Meeting was called to order by President Kim Adams at 7:00 pm on January 30, 2023 at Camp Chandler on Lake Jordan.

President Adams thanked everyone for being there and declared that a quorum was present. Besides being a quarterly membership meeting, it also serves as the annual business meeting. She welcomed everyone and new members introduced themselves.

Elmore County Commissioner, Henry Hines spoke briefly of the January tornadoes. As a HOB0 member and public figure, he is working to help those impacted by the storms. A contract started today, after a national disaster was declared, for outside help with storm clean up, so the county can concentrate on clearing roads and other work. Because of the declaration, federal funds will cover 75% with the state and county splitting the other 25%. A special thanks to the volunteer firefighters. They could use donations for saws, generators, and outfitters gear since the recent storm response.

Doug Gordon, with his wife Debbi, hit by the January 3rd tornado, thanked the HOB0 for all the help. HOB0 provided totes, food, water, gloves, and the county provided tarps, water. He thanked the volunteers that helped clear the roads and neighbors that brought supplies by water. They are planning to rebuild.

Kim reminded the gathering that our hearts go out to all the victims, and if you suffer a disaster – tornado, fire, etc. – reach out to the HOB0. We are here to help our members, friends, and neighbors.

A motion was made and seconded to approve the minutes of the October 24, 2022 meeting. The motion carried.

Holly Baylis presented the Financial Report. 2022 ended with a balance of \$63,278. Available for HOB0 discretionary use is \$36,709. See Financial Report for details. Around 60 members have paid their 2023 dues, with around 250 remaining. If you haven't done so, please pay. You may either pay online, through the website (<https://www.lakejordanhobo.org>) or mail them to Lake Jordan HOB0, PO Box 431, Wetumpka, AL 36092-0431. Dues are \$25 per household.

The 2023 budget was presented as Lake Jordan HOB0 Resolution 23-01 for discussion. A motion was made and seconded to approve the budget as presented. The motion carried.

### Committee Reports

Water Quality – Judy May reiterated that supplies were hard to get for bacteria testing. She reached out to Alabama Water Watch in Auburn and they have provided a new method for scanning. Where the old coloscan testing required media be kept frozen until used, petri dishes and incubators must be maintained. She briefly demonstrated the new method and explained it should be much simpler. Training is available for the new medium on February 23 (12:00-1:00 or 5:00-6:00) for current monitors. Training for new monitors will start online tomorrow, January 31, with an in-person class February 16 at Auburn, or Feb 28-Mar 21 online with in in person class March 23 in Birmingham. Contact Judy if you would like to be a monitor. We currently have no coverage in Blackwell Slough area. Only 4 people monitor the Holtville side and 5 on the Titus side.

Lake Safety – Dave Kowalski warned that there is a lot of stuff floating in the lake, including many giant trees. Also, the lake is very foggy this season and some boaters go way too fast for the conditions. He recommended cutting your motor and listening for approaching craft before crossing in the fog. He is aware of missing buoys north and south of Weoka Creek. He has been talking with new Marine Patrol Regional Commander Steve McWaters, and Alabama Law Enforcement Agency's Marine Patrol (AMP) is working to replace those buoys.

Fireworks – Nothing to report. Shirts and cups are available for sale as part of the fireworks fundraising.

Newsletter and Facebook – Cliff Clemmons asked for topics of interest be forwarded to him for input to the newsletter. Gary Amerson requested photos submitted for the calendar contest be large (in Megabytes, not kilobits; approximately 300 dpi) and landscape orientation (wide, not tall) for best use in the calendar. Kim mentioned that the voting via the Facebook page is open to the public, but only paid HOB0 members will get a free calendar in 2024.

## **Minutes of the Quarterly Membership Meeting—Continued (Pg 2)**

Governmental – Logan Gray passed along the regular session begins March 7.

Environmental – Nothing to report. They are still working the sediment issue.

Scholarship – Gayla Littlejohn announced the scholarship committee is accepting applications for the second annual HOBO scholarship.

Lake Clean-up – Clean-up starting this year, is moved to the first weekend in May, largely to avoid Alabama Power conflicts. Mr. Hines mentioned Elmore County Clean Up will be March 31 – April 2.

### **Guest Speakers**

Elmore County Emergency Management Agency

Keith Barnett, Director of the Elmore County Emergency Management Agency, began by introducing his team; David Brunson, Deputy Director; Julie Lawrence, Emergency Management Specialist; and Bethany Elliot, a recent Emergency Management Specialist addition to the office with state level experience.

Debris – Right of Way debris: the county has engaged a contractor to pick up debris from the Jan 12 tornado. The debris must be on the right of way, divided into separate piles for woody debris and Construction & Demolition (C&D) debris (like roofing or insulation). FEMA invoked the Stafford Act and will not merge the Jan 3 and Jan 12 events into the national disaster declaration, so areas that were impacted by both storms should declare Jan 12 damage to be included in the cleanup. As a reference, the Willow Springs storm took 6 weeks to pick up 4,000 cubic yards of debris. This storm is estimated to have created 30,000 – 40,000 cubic yards of debris, so it will take a while. The county commissioner and county engineer are closely monitoring the contract to get the work done.

If your right of way is full, let the EMA know and you can be added for cleanup in a second pass.

If you have widespread downed trees, there are no FEMA programs to assist, but the USDA Farm Services Agency in Wetumpka has programs that may be able to help clean up and replant forestry. Jeff Smith can help you through the many steps for “cost matching” (which means reimbursement after you complete the work).

Lake Debris: EMA has observed debris from the Jan 3 and 12 storms in the lake, to include trees, submerged boats, and boat houses. Video from helicopter, drone, water, and land has been filed with state EMA. Elmore Co EMA is working with another state agency to get debris they observed near Island Road and Holiday Shores. It has been acknowledged and is waiting for funding. Without a declared disaster, we need state funding.

EMA has handouts available to help with the FEMA application and appeals process. (Expect to hear No at your first application.)

The Disaster Resource Center at the Elmore County Courthouse is available to assist. The Small Business Association may have small interest loans to help with things like the under-insured gaps and to help mitigate damages.

Storm Shelters – After working for over 10 years, the county finally obtained funding after Zeta. The \$60,000 is enough to help about 10 people from the waiting list of 200. Help will be in the form of reimbursement. The county filed for those 10 people about 9 months ago and are still waiting.

Storm Notification – The Island Road storm siren took a direct hit in the Jan 3 tornado. Damage was not noticed until after the Jan 12 storm. It has a broken antenna and bad battery – parts have been ordered.

If you rely on the siren for your notification, PLEASE stop. Get a weather radio and sign up for phone notifications. The EMA system had been calling home phones, but Commissioner Hines brought funding to add cell phones (determined by billing zip code). On Jan 12, 20,000 calls were made in an instant.

Elmore County Disaster Relief Fund – Unlike some national systems (United Way), 100% of money raised goes to providing relief, not to any executives or staff.

Saturday, Feb 4, the Cattlemen's Association will host a \$10 Ribeye sandwich sale outside Winn Dixie in Wetumpka. Every penny earned will go to the relief fund.

Community Emergency Response Team (CERT) – A new 1 week class will start Monday, Feb 27. Classes will be Mon, Tues, Thur, & Fri 6-9pm with disaster simulation on Saturday and graduation the following week at the courthouse. (This replaces the previous 9 week course.) Local government prepares for everyday emergencies.

However, during a disaster, the number and scope of incidents can overwhelm conventional emergency services. The CERT course is designed to help you protect yourself, your family, your neighbors and your neighborhood in an emergency situation. CERT is a positive and realistic approach to emergency and disaster situations where citizens may initially be on their own and their actions can make a difference. While people will respond to others in need without the training, one goal of the CERT program is to help them do so effectively and efficiently without placing themselves in unnecessary danger. In the CERT training, citizens learn to: manage utilities and put out small fires; treat the three medical killers by opening airways, controlling bleeding, and treating for shock; provide basic medical aid; search for and rescue victims safely; organize themselves and spontaneous volunteers to be effective; and collect disaster intelligence to support first responder efforts.

Coosa Riverkeeper

Justinn Overton, Riverkeeper and Executive Director, and Abby Brown, Outreach Manager, presented for Coosa Riverkeeper. As a nonprofit, Coosa Riverkeeper keeps a 3-year strategic plan. This year, their focus is Lake Jordan. Please contact them if you would consent for them to use your dock for testing. Riverkeeper staff patrols 5 lakes and dozens of creeks to document both pollution and beauty and stay in tune with what's happening on the river. They work to educate the public about the value that the Coosa River brings to our community, economy, and our environment. The Swim Guide program provides water quality data and swim safety information so families can make informed decisions about where to safely enjoy the river. ("Get the skinny before you dip.") The Fish Guide program works to educate fishermen about fish consumption advisories and fishing best practices. Coosa Riverkeeper also advocates for river and the thousands of families who rely on it for fun, food, and property value. Coosa Riverkeeper actively works to educate elected officials and policy makers at all levels of government on matters related to the protection and restoration of the Coosa River. They monitor 1100 registered polluters on the river.

They have a staff of 6 and monitor 4,892 square miles, 1,238 miles of shoreline, 19 threatened or endangered species, 12 counties, 6 reservoirs, 6 critical habitat sections, and 1 whitewater section. Last year CoosaRiver.org issues 170 email alerts.

The Coosa River was named the 5th most endangered river in the US in 2022.

Popeye the Sailor man was created in Gadson, Alabama and was originally based on the Coosa River.
