Understanding the Alabama-Coosa-Tallapoosa (ACT) River Basin Compact by Steve Mathies

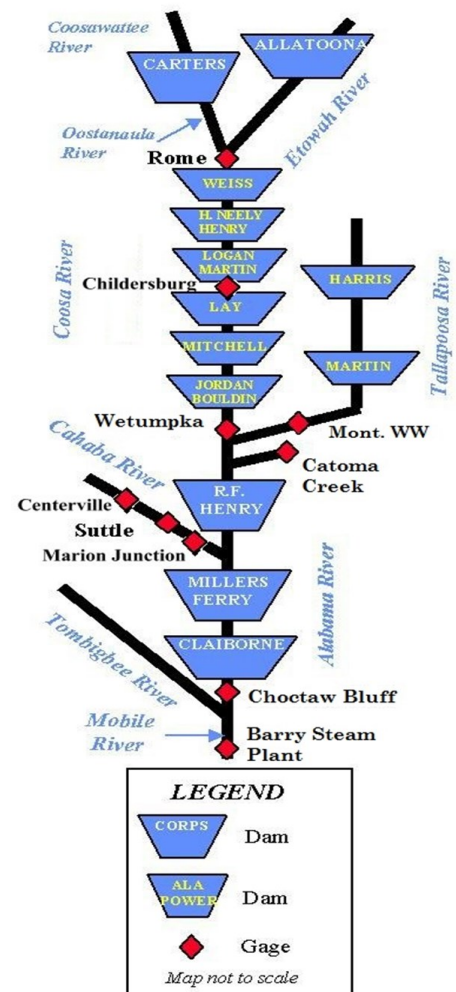
The Basin ACT River Compact is an interstate compact between Alabama and Georgia that apportions the waters of the ACT drainage basin. In 1981, 1986, and 1988 the region suffered extended periods of drought. The droughts prompted a comprehensive study focusing on water resource issues in the ACT basin in Alabama and Georgia. This Compact among the States of Alabama and Georgia and the United States of America was developed for the purposes of promoting interstate mutual benefit, removing causes of present and future controversies, equitably apportioning the surface waters of the ACT, engaging in water planning, and developing and sharing common data bases. The Compact was approved by Congress in 1997.

The ACT River Basin Compact is administered by the ACT Basin Commission. The Commission is comprised of one member representing the State of Alabama, one member representing the State of Georgia, and one non-voting member representing the United States of America. Each State has one vote on the ACT Basin Commission and the Commission makes all decisions and exercises all powers by unanimous vote of the two State Commissioners. The purpose of the Compact to develop an allocation formula for equitably apportioning the surface waters of the ACT Basin among the States while protecting the water quality, ecology, and biodiversity of the ACT, as provided in applicable Federal laws. The Compact recognizes that the United States operates certain projects within the ACT Basin that may influence the water resources within the ACT Basin. The Compact recognizes that various agencies of the United

States have responsibilities for administering certain Federal laws and exercising certain Federal powers that may influence the water resources within the ACT Basin. The States of Alabama and Georgia mutually agreed to the principle of individual State efforts to control man-made water pollution from sources located and operating within each State and to the continuing support of each State in active water pollution control programs. The States of Alabama and Georgia agree to cooperate in maintaining the quality of the waters of the ACT River Basin. Water Control Manuals were developed for each individual water control structure located on the Coosa River and these manuals are revisited on a 5-year basis to accommodate changing needs of the communities and industries that depend upon the waters controlled by them.

In response to drought conditions, in 2018 the State of Georgia requested a reallocation of water storage for Allatoona Lake given its role in water supply for several Georgia communities, including Atlanta. At that time revised flood operations at two Alabama Power Company (APC) owned projects – Weiss and Logan Martin Reservoirs – were also evaluated. In May 2022, those requested changes to the Water Control Manuals for Weiss and Logan Martin were approved.

Given the likelihood of more frequent and more severe droughts in the future because of climate change and the increased need for fresh water supply to support growing communities like Atlanta, it is critical for our Lake Jordan HOB to actively engage to protect the pool elevation of the Lake Jordan now and into the future. The current focus on renewable energy sources, like hydropower, should benefit our needs by continuing the current operation by Alabama Power. To accomplish that objective, I have engaged with the unit within the U.S. Army Corps of Engineers, Mobile District that oversees the ACT Program to ensure we are made aware of all requests and scheduled meetings that could impact water elevation or water quality for Lake Jordan. I am further requesting notification of all meetings of the ACT River Basin Commission and intend on attending those as well. I welcome input and participation from any of my fellow HOB members.

Minutes of the Quarterly Membership Meeting October 24, 2022

The Lake Jordan Home Owners/Boat Owners Association Quarterly Membership Meeting was called to order by President Kim Adams at 7:00pm on October 24, 2022 at Camp Chandler on Lake Jordan.

President Adams thanked everyone for being there and declared that a quorum was present to conduct business. She welcomed everyone and new members and guests introduced themselves.

Brett Wilkinson presented the Financial Report dated June 30, 2022, with an ending non-restricted cash balance of \$37,240.71. There is \$23,384.95 in the fireworks fund and \$3,207.44 in the scholarship fund. A question was raised about the cost of the fireworks. Brett stated that the cost went up to \$13,350.00 this year.

Kim announced the HOBO Association made a \$250 Donation to the Camp Chandler Halloween Carnival.

The Bacteria Test Chemicals are on backorder until mid-November, however bacterial testing generally takes place during the swimming season (May – September). Chemical testing takes place year-round, and Judy has plenty of those chemicals available for the monitors. Kim recognized and thanked the water monitors that were present at the meeting.

Lake Safety – Dave Kowalski reported that there is buoy missing at the Lake Jordan marina. To report missing or damaged buoys, please call 334 676-7099 or email Qiana.jackson@alea.gov. Dave reminded everyone to be sure to wear life preservers while on the water. Falling in cold water can cause one to become paralyzed. Also, don't forget to protect your boat by having it winterized.

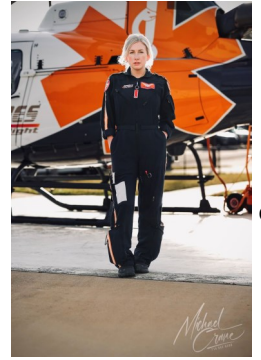

Notable Neighbors by Ann Brantley

Welcome to our series of "Notable Neighbors" where we highlight the interesting and accomplished residents of Lake Jordan. Our first featured neighbor is **Ms. Alaina Starke, RN, CEN, CFRN**. These letters stand for Registered Nurse, Certified Emergency Nurse and Certified Flight Registered Nurse, respectively. Alaina has been a resident of Lake Jordan for about two years and is currently employed by Haynes Life Flight as a critical care flight nurse.

As a flight nurse, Alaina operates with her certified flight paramedic partners in helicopters that are equipped as "flying ICU's." This invaluable resource allows for the stabilization and rapid transport critically ill or injured patients from the scene of accidents or from local hospitals to facilities that provide higher levels of care. All members of the flight crew are highly trained and certified and carry state-of-the-art equipment including ventilators, critical care medications, blood products, and medication infusion pumps. With two centrally located bases in Troy and Wetumpka, Haynes Life Flight partners with local fire departments, EMS services, and hospitals to transport patients as far South as Tallahassee, East to Atlanta/Augusta, West to Mississippi, and North to Tennessee and ensure they receive the best possible care while cutting the time it takes to get there in half!



Haynes has been a valued member of the community for many years and provides a vital service to the area. During recent natural disasters, the Haynes staff offered their time and resources to help in any way they could. Even employees who were not on duty jumped in to assist. We are incredibly grateful for their dedication and for all those who came to their neighbors' aid in difficult times.

I have known Alaina for many years and consider her one of my own. The Lake Jordan community is fortunate to have her. Despite her demanding work schedule, Alaina agreed to sit down with me to share some valuable information for our neighbors.

With snake season upon us, it's important to talk about what to do in the event of a snake bite. Alaina provided some guidelines on what to do and what not to do.

DO:

Remain calm and call or have someone call 911. You will be directed on next steps and/or where to go.

If it is safe to do so, take a picture of the snake, but do not risk another bite or injury trying to kill it or take pictures. You can still be bitten and envenomated with a snake head that's been removed!

Depending on where the bite is, remove rings, jewelry, socks, and shoes to prevent constriction if swelling occurs.

Draw a circle around the bite site and mark the time with a permanent marker.

DO NOT:

- Apply a tourniquet.
- Apply ice or heat.
- Cut the site and attempt to suck the venom out.
- Use a commercial snake bite kit.

This is just a basic overview of what to do if you are bitten by a snake. It's also important to learn how to identify poisonous snakes in the area, learn ways to lessen the chance of a snake bite, and know what to do in the event of one. There are plenty of resources available for researching this information but here are a few websites you may find valuable:

In addition, I asked Alaina to share the top five things she would never do as a flight nurse:

- Not wear a seatbelt.
- Not get CPR certified - it's simple, free in many places and could very well save a person's life. Some organizations offer Hands- Only CPR training as well!
- Jump off a rope swing into any body of water with a current - structures and depths change, you never know what you may be jumping into!
- Ride an ATV, side-by-side, bike, or horse without a helmet.
- Get on any boat or watercraft vessel with an intoxicated driver. It's also important to know the rules of the water and laws regarding boating!

Finally, here's a fun fact about Alaina - her four-legged companion and co-worker is Tallulah B (Tally B), a beautiful "sheepadoodle" that goes on every shift with her and patiently awaits her and the crew's safe return when they are called to duty.

has rights to use the pictures in future publications. Calendars will be given to members when paying their 2024 dues. Nonmembers will have the opportunity to purchase a calendar.

Guest Speaker Tyler Burgener from the Alabama Wildlife Federation was present at the meeting to talk to and educate the membership about snakes that we may encounter on Lake Jordan and how to safely deal with those encounters and be more comfortable coexisting with snakes. There are approximately 50 species of snakes in Alabama which is a larger number than most states due to the great resources (forests, rivers, lakes, mountains, etc.) our state offers that are attractive to both people and animals. 6 species of the 50 are venomous and only 3 of those are found in the local tri-county area. Contrary to popular belief, a triangular head on a snake does not mean that it is venomous. Many non-venomous snakes will flatten their heads to look triangular as a defense mechanism to appear bigger. Also, one shouldn't try to determine if a snake is venomous from the shape of the snake's eyes (round vs. cat like pupils). There are resources such as Facebook groups (Alabama Reptile and Amphibian ID & Education and Snake Identification: Discussion and Resources) where you can post a picture of a snake and get a quick identification from an expert. The Department of Conservation's Outdoor Alabama website has a searchable wildlife section where you can also find IDs from pictures. All snakes are coldblooded. They are less mobile in the winter and are most often seen in the spring and early fall. In the summertime, snakes are generally more active in the mornings and evenings to avoid the extreme heat. People fear snakes because they bite. In almost all cases, self-defense is the reason that a snake would bite a human. Snakes eat rodents, turtles, slugs, other snakes, etc. When you encounter a snake, keep a safe distance. Always be prepared and keep a watch out for them when gardening, hiking, walking in the woods, etc. because one of their most used defense mechanisms is to be camouflaged and to blend into their habitat. Their second mode of defense once it feels threatened is to flee to get away from the threat. The snake's third defense mechanism is to give some sort of display such as the rattlesnake shaking it rattles or a cottonmouth displaying its wide-open white mouth. The hognose will actually play dead. The fourth defensive mechanism is to strike and bite. A non-venomous snake bite is harmless. Venomous snake bites require medical attention. Twenty-Five to Fifty percent of snake bites are dry bites meaning that they are not actually injecting venom when biting. The National Snakebite Support Facebook Group is a great source to get treatment information from medical professionals across the country for humans as well as pets that are bitten by a snake. All snakes can swim on top and underneath the water. Many snakes seen in the water are nonvenomous water snakes. Tyler stressed that snakes are beneficial to humans and shouldn't be killed. The Copperhead snake's venom contains a protein that has been proven to stop the spread of cancer cells in breast cancer patients. All Snakes eat rodents. One of the most common snakes seen is the non-venomous rat snake which is great to have around for rodent control. Some snakes are federally protected and killing them will result in a fine. King snakes are protected in Alabama. They are common to the area, not a threat to humans, and they are good to have around especially for those who fear snakes because the King snake eats venomous snakes. Most snake bites happen on the hand. On average, about 5 people die from snake bites each year in the U.S. and that is due to them not getting proper care in a timely manner. Store bought repellents are not effective in keeping snakes off one's property. One can't eliminate snakes from coming onto his/her property, however, minimizing the areas around your home where snakes would hide such as firewood piles, or overturned boats, etc. will help. Bird feeders draw rodents which are a food source for snakes. Spaces under decks and storage units are great hiding places for snakes. Tyler has agreed to come back to speak to the membership again in an upcoming quarterly meeting and will bring some snakes with her for informational purposes. 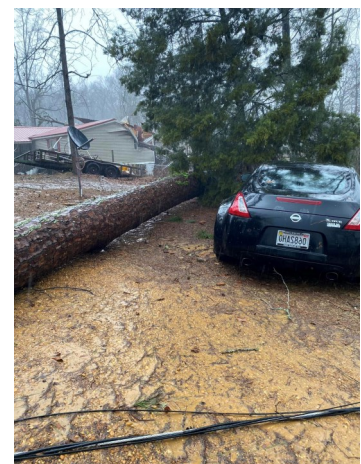
Governmental Affairs – Logan Gray reminded everyone about the upcoming General Election on November 8th. Remember, every vote counts!
