## Picking Up the Pieces



Wetumpka, Alabama made national news on January 19, 2019 ... for all the wrong reasons. Homes, businesses, government offices and churches were among the many buildings badly damaged or demolished when tornadoes struck central Alabama.

The National Weather Service confirmed that the storm started near the river with wind speeds of 120-130 mph. This EF2 tornado covered 18.2 miles and had a maximum width of 700 yards with the blunt of the storm striking Wetumpka's downtown river-front area.

Wetumpka's historic First Presbyterian Church, built in 1856, was reduced to rubble; as well as, parts of First Baptist Church of Wetumpka and approximately 25 neighboring homes. The Wetumpka Police Department, senior citizens center and recreation center were also lost.

The "bright spot" of this horrific event was that there were somehow no fatalities or serious injuries reported. Among all the destruction, all life was spared.

Local first responders were immediately on the scene and took control of the chaos like true professionals. In the days that followed, first responders from across the River Region and volunteers from around the southeast flooded the city to offer helping hands and hope to our community. Local restaurants fed the masses without thought of profit's lost and financial support came pouring in.

The need is great and will continue for some time to come. If you would like to help, donations can be made through the Central Alabama Community Foundation's Wetumpka Tornado Relief Fund. This nonprofit, which is a River Region charitable foundation, started in 1987 and plans to use the donations to support immediate; as well as, long-term needs of citizens in Elmore County. More than thirty days out from this life-changing event, Wetumpka is still cleaning up but with visions of brighter days to come. Because of the people in our local community and the faith that was clearly on display following this storm, there is no doubt that Wetumpka will rebuild stronger than ever before.

**Dues are \$25.00 per year.** We also encourage members to consider a financial contribution to the Lake Jordan Fireworks Fund.





## Lake Jordan Home/Boat Owners Association Minutes of the Quarterly Membership Meeting

### **January 28th, 2019**

The Lake Jordan Home Owners/Boat Owners Association Quarterly Membership Meeting was called to order by President Jeff Royal at 7:00pm on January 28th, 2019 at Camp Chandler on Lake Jordan.

President Royal thanked everyone for the large turnout and declared that a quorum was present to conduct business. He welcomed everyone, and new members and guests introduced themselves. Jeff also recognized long time member and volunteer Barbara Dreyer who was celebrating her birthday.

A motion was made and seconded to approve the minutes from the October 22nd, 2018 Quarterly HOBO Association meeting. The motion carried.

HOBO Treasurer Tommy Counts presented the Financial Report dated December 31, 2018 with an ending non-restricted cash balance of \$37,487.71. Discussion took place regarding the possibility of funds earmarked for the Lake Safety Committee being spent to replace missing buoys in various areas of the lake. It was determined the State Marine Police are responsible for providing and replacing the buoys and that the HOBO's responsibility is to inform them about dangerous areas that need to be marked.

The 2019 Lake Jordan HOBO Operating Budget was presented to the membership for review and approval. After a brief discussion, a motion to approve the budget as written was made by Gerald Hardy and seconded by Tim Owen. The motion carried.

The annual \$1000 checks were presented to local fire departments and Elmore County Search & Rescue" that serve Lake Jordan and the surrounding areas. Representatives from Titus, Holtville and Buyck fire departments and the Elmore County Search and Rescue attended the meeting to receive the contributions for their departments.

Wes Anderson, a representative from Alabama Power's Water Management and Environmental Affairs Division was present at the meeting to talk about the Alabama Power Aquatic Vegetation Program and the non-native invasive (bad) aquatic plants (Water hyacinth, Water Lettuce, Watermilfoil, and Hydrilla) some of which have been seen in Lake Jordan. Hydrilla has been found in the Walter Boulden Dam area of the Lake and is currently being treating by Alabama Power

to prevent spreading. However, treatment is very costly. Water Lettuce has also been seen in various parts of the lake. If you see water lettuce floating on top of the water, it can be easily be destroyed by pulling it out of the water and thrown on dry land. It cannot survive on the land. If you see any suspicious vegetation, take pictures, get GPS coordinates of where it is located and call 205 257-2393. To help keep invasive plants from entering Lake Jordan, it is very important to thoroughly rinse boats and boat trailers after removing them from other lakes and prior to putting them into our Lake. A very common non-harmful aguatic plant known as Water Willow exists throughout the Lake and can also be treated and removed. For all aquatic plants concerns, please call Alabama Power at 1800 Lakes11 or for more information, please visit https://apcshorelines.com/aquatic.

Along with the Aquatic Management Program, Alabama Power's Water Management and Environmental Affairs Division also oversees the Mosquito Control Program, Fish Habitat Enhancement Program and the Alabama Power Renew Our Rivers Program. Wes was excited to report that 16 million pounds of trash and debris have been removed from Alabama's water ways and lakes during the 20 years that the Renew Our Rivers Program has been in existence.

Brenda Basnight was recognized to give an update on the upcoming CPR class. Two classes will be held at Camp Chandler on February 5th, with the 1st class starting at 2pm and the 2nd class starting at 6pm.
