

Did you know....

The roots of many phrases and words we use today can be traced to "life afloat?" Read below for the conclusion of nautical sayings that have "come ashore over the years" courtesy of BoatU.S. Magazine's contributing editor, Frank Lanier.

Know the ropes

One requirement of shipping aboard as an able seaman (versus an ordinary hand) was a thorough knowledge of all ropes pertaining to the vessel's operation, which on a square-rigger could equate to miles of cordage. Crew members achieving that level of skill were said to "know the ropes."

Posh

The late 19th and early 20th centuries witnessed the birth of the golden age of travel. Huge, opulent luxury liners began crossing the globe, all constructed to provide the wealthy of the day a means of traveling about in style - meals equal to the world's finest hotels, orchestras for dancing, a small army of stewards to wait on passengers hand and foot. One perk available for those willing to shell out a little extra was found aboard the P&O steamship line, a major shipping company of the day serving China and India. Well-heeled travelers always requested the cooler cabins located on the shady side of the ship while crossing the Indian Ocean, cabins that P&O charged a premium for in addition to the already substantial fare.

As port was the shady side of the outbound leg (with starboard being the sought-after side of the return or inboard portion of the trip) passengers who requested such cabins had the letters POSH (port outward, starboard homeward) printed on their tickets, introducing a new word for elegant or fashionable into the English language.

Scuttlebutt

The scuttlebutt was a small cask (called a "butt") of water placed on deck each day for members of the crew to drink from, normally by dipping a chained tin mug through a small hole, or scuttle, cut into the barrel's side. The men could drink as often as they liked but were allowed only one cup per trip to conserve water. Another conservation practice was doing away with the scuttle entirely, with the crew drinking from the cask via an old musket barrel shoved through the bung.

As noise had to be kept to a minimum on deck (so commands and orders could be heard) and belowdecks as well (where off-watches were trying to sleep), the scuttlebutt was one of the few common areas where a sailor could relax while mulling over the day's events with fellow Tars. As such, the word itself eventually came to mean "rumors" or "gossip."

Square Meal

A solid, hearty meal said to be derived from the square wooden platters hot meals were served upon aboard ship in good weather.

Toe the line

Sailors called to muster were told by the bosun to "toe the line," meaning they were to form up in a straight line, toes to one of the ship's deck seams.

Windfall

Used to describe an unexpected stroke of good fortune, this is another popular term that has its roots in nautical language. During Britain's emergence as a growing naval power, the crown proclaimed all standing trees of a certain size located within His Majesty's realm belonged to the Admiralty to ensure an adequate supply of wood for shipbuilding. Landowners were forbidden to touch trees so designated. However if one was blown down via an act of God, the owner was free to claim and use this wind fall as he saw fit.

Touch and go

Often used to describe a tricky or delicate situation, this phrase refers to a ship touching bottom with her keel but being able to continue without grounding solidly. It especially highlights those suspenseful few seconds all boat owners experience at some point – that period of alternating cures and prayers between touching bottom and reaching the safety of deeper water.

Lake Jordan Home/Boat Owners Association Minutes of the Quarterly Membership Meeting April 25, 2022

The Lake Jordan Home Owners/Boat Owners Association Quarterly Membership Meeting was called to order by President Kim Adams at 7:00pm on April 25th, 2022 at Camp Chandler on Lake Jordan.

President Adams thanked everyone for being there and declared that a quorum was present to conduct business. She welcomed everyone and new members and guests introduced themselves.

It was noted that 2 corrections need to be made to the January 24th, 2022, Quarterly Minutes. The Vice President should have been listed as "Jill" Murchison (not "Jim" Murchison) and under the Fireworks Committee, it was reported that the "2021" Lake Jordan Fireworks T-shirt design is being worked on and year should have been "2022". A motion was made and seconded to approve the minutes with the corrections. The motion carried.

Brett Wilkinson presented the Financial Report dated March 31, 2022, with an ending non-restricted cash balance of \$39,905.90.

Each year, \$1000 grant checks are presented to each of the Volunteer Fire Departments and the Search and Rescue Department that serve Lake Jordan and the surrounding areas. Brett and Kim presented a check to a representative from the Buyck Fire Department. The association is still awaiting the paperwork from each of the other departments. Once the paperwork is received, they will also receive their annual grant checks.

Gayla Littlejohn gave a report about the Lake Jordan HOBO Scholarship Program and introduced the First Annual Scholarship Recipients. She began by saying that committee received several very impressive applications which made it a very difficult decision when choosing who to award the scholarship grants to. Gayla introduced Borden Lash and Richard Mathews and presented each with a \$1000 Scholarship Check, a Certificate and a 2022 Lake Jordan Fireworks T-shirt. Borden is a Senior at Lamp High School and plans to attend Mississippi State University to study Child Development and then plans to further her education by going to school to become an Occupational Therapist. Richard is a Senior at Macon East Academy and plans to attend the University of Alabama to study either Mechanical Engineering or Pre-Med. Congratulations to both Scholarship Recipients. Gayla reminded everyone that the committee will have their Boston Butt Sale Fundraiser again this year for pickup on the Labor Day weekend.

Committee Reports

Lake Clean-Up - Brenda Basnight reported that the 2022 Lake Clean Up was highly successful again this year and everyone had a good time. She recognized and thanked the sponsors, Ernie and Terry Pritchard for cooking the hotdogs and hamburgers, the large number of volunteers, the Holtville Fire Department for helping to unload boats, the Area Reps for helping to organize the event in their Areas and, of course, everyone who participated in the Clean Up. Brenda didn't know the amount of trash that was removed since the dumpster was being picked up and weighed the day of the quarterly meeting. She was told that it would be a couple of days before she would find out the how many tons of trash was removed this year. She indicated that the information will be available in the next HOBO Newsletter. Close to 300 T-shirts were given out and there are just a few remaining, mostly size small adult and all youth sizes to give away. Brenda informed the membership that she and Allan will be stepping down as the Chairs of the Lake Clean Up Committee. Their Son and Daughter-In-Law, James and Gayla Littlejohn will take the reins and Chair the Committee with Allan and Brenda assisting. Kim Adams thanked Brenda and Allan for Chairing and Organizing the Cleanup and for their tremendous contributions toward making it successful every year.

Lake Safety - Dave Kowalski announced that the Marine Police were currently replacing the 6 missing hazard buoys. He said that we have a new water patrol officer, and he is very proactive and willing to help. If you know of any other buoys that need to be replaced, please call the marine police at 800.432.7389 to report it. The Christmas Tree habitat project was very successful and approximately 100 trees were put out. The coordinates of where the trees were dropped will be posted in the HOBO newsletter. Dave reminded everyone to do their yearly safety checks. Check your life jackets, boat houses, and make sure your GFI receptacles are functioning correctly. Make sure your fire extinguishers are up to date. Also, please make sure the lights on your boats are functioning correctly.

Kim recognized and thanked Dave Kowalski for his efforts and for being very proactive with getting the buoys replaced. The marine police having no cable available was stalling the project. Dave was able to get the cable for them to move forward with the installation of the replacement hazard buoys.

Coosa River Basin - Kim announced that the Coosa River Basin Committee is being revived and she will be working with Steve and Linda Mathies (who will be Chairing the committee). The initial focus of this committee will be addressing the issue of sediment deposits in the lake. Steve and Linda both have extensive background experience with coastal restoration and dealing with environmental issues. They are already working with the Alabama Power Shoreline Management Office and the Alabama Power Environmental Department. Their plan is to reach out to and partner with the Elmore County Commission, ADEM and any other agencies that can assist with remedying this situation. A plan of action is currently being drafted and a letter from Steve will appear in the July HOBO Newsletter. He will also be the Guest Speaker at the July HOBO Quarterly meeting. Please contact Kim Adams if you are aware of any areas on the lake that are experiencing a problem with sediment deposits or if you would like to be a part of this committee.

Fireworks - Nikki Miller named and thanked all the Businesses that are sponsoring the 2022 July 4th Fireworks Show. She has the 2022 Lake Jordan Fireworks T-shirts available for sale so please contact her if you are interested in purchasing one. Of course, all proceeds go the Fireworks fund. Kim commended Nikki for the great job she has done and is continuing to do with our Annual Fireworks show.

Kim announced that Holly Baylis will now be handling the duties of HOBO Treasurer. Holly is currently already Chairing the Membership Committee and she and her husband, Randy, are Chairing the July 4th Boat Parade Committee. Thank you so much to Holly for handling all these responsibilities. Joyce Wright has agreed to continue to serve as the HOBO Assn Secretary since Gayla Littlejohn is Co-Chairing the Scholarship Committee and the Annual Lake Clean Up Committee. Economic Impact of Fishing Tournaments

Elmore County Economic Development Authority (ECEDA) works with various organizations to bring revenue into Elmore County via fishing related events. ECEDA does not have authority to say yes or no nor choose what organizations can or cannot use public boat ramps. What we can do is work to make tournament day(s) more organized to offer a better experience for our visitors as well as residents.

In this fiscal year, fishing tournaments have produced just shy of \$1 million economic impact for Elmore County. Some tournaments receive financial support; while others receive assistance in several ways. A typical tournament entails ECEDA attending the rules meeting to encourage spending in Elmore County, blocking off parking in non-designated areas, handing out trash bags to each boat prior to launch, monitoring parking during the weigh-in, picking up trash after the event if necessary, and checking fish release after the tournament.

Most complaints we receive involve tournaments without ECEDA involvement. Each tournament is a learning experience and we have seen event related issues decrease drastically. We appreciate the dedication and challenging work of the HOBO association. Tournament days can be hectic but know that ECEDA is committed to making these days less impactful on residents, non-tournament anglers, and recreational boaters. A Message from Steve Mathies-Coosa River Basin Committee Chair

Uncontrolled introduction of unwanted sediments into the lake

We live on the lake because we love to swim in it, boat on it and eat the fish we catch from it. For many folks, including us, our use of the lake is being diminished because of the uncontrolled introduction of unwanted sediments into the lake. The sediment flow is originating upstream from our property and, due to the abnormally heavy rainfalls experienced over the past 3-5 years, increased erosion along county roads, and the clearcut forestry practices employed on neighboring properties, is deposited in the lake resulting in reduced water depths. Those reduced water depths prevents use of pleasure and fishing boats, eliminates historic swimming areas, and endangers speeding boaters that are not aware of the recent sedimentation and resulting reduced water depths.

Alabama Power operates the lake in compliance with its federal license granted by the Federal Energy Regulatory Commission. The Alabama Department of Environmental Management (ADEM) has the regulatory responsibility for water quality in the State. While Alabama Power is not responsible for the sedimentation occurring in our slough, in a good faith effort to assist in reducing the continuing sedimentation, Alabama Power worked in partnership with us to perform maintenance on an existing rock weir with drainage pipes and a sediment trap on the upstream side of the weir located on Alabama Power lands. The project was successful, and the sand trap filled within six months. In order to effectively reduce sedimentation in the lake, a long-term solution for addressing upstream erosion needs to be established.

We will continue to work with Alabama Power and ADEM to appropriately address our problem as we and Alabama Power are not the source of the sediment contamination, but we are the ones that suffer the loss of our use of the lake. I truly believe that the working relationship we have fostered with Alabama Power and ADEM is a model that we, as lake residents and HOBO members, can use to make the lake better for everyone.

I suggest that we begin to understand and document the extent of the erosion and sedimentation problems by developing a lake map with all the erosion and sediment contamination problems identified. Once identified, current conditions documented, and history of problem noted, then future notes related to site monitoring can be added. The goal is to have all problem areas identified and solutions/remedial actions agreed upon.
